### PLEASE READ CAREFULLY & SIGN BELOW

If pet is hurt or becomes ill, Pawsitively Perfect has permission to call or take pet to veterinarian of our choice if pet's vet is inaccessible; or give other advisable attention, with our discretion and judgment, and such expenses will be paid promptly by owner unless injury is direct result of negligence of Pawsitively Perfect. We will not be held responsible for any sickness or injury *caused by the pet* to itself during grooming. Pawsitively Perfect is not responsible for any accidental death of pet of the nature of pre-existing health condition or natural disasters (fire, storm, flood, etc.). See Waiver Attached.

Pawsitively Perfect will not be held responsible for clipper burn and/or minor nicks resulting from grooming of matted, neglected coats or for irritation caused by removing coat from pets possessing mild to severe skin allergy, nor will we be held responsible for stressful effects grooming may have upon an elderly pet. Pawsitively Perfect LLC must be notified of any claims by owner regarding compensation for medical attention given as a result of alleged negligence on our part within 48 hours. Prior to any claim, permission is given to consult the attending veterinarian regarding treatment given.

We reserve the right to charge additional fees for services we consider over and above the norm covered by our standard rates. There WILL be additional charges for excessive de-matting (\$1.00 per min)! If your dog is excessively **HARD TO HANDLE**, we will add a \$15-\$40 **HARD TO HANDLE FEE** on top of your regular groom price. We also reserve the right to refuse service to customers whose pet may pose a threat to us or to the other pets left in our care, whether it be an aggression problem, health problem, or parasite problems (other than fleas).

**I understand that Pawsitively Perfect has a NO SHOW policy and there is a \$45 fee per dog that will be assessed in the event of a No-show for a scheduled appointment, this fee will need to be taken care of before I can book any future appointments. I understand that I can avoid this fee by cancelling my grooming appointment no less than 24 hours prior to said appointment.**

**I understand it is my legal responsibility** to disclose to Pawsitively Perfect, to the best of my knowledge if my pet has bitten anyone in the past (including another groomer). I also understand that I, as the owner, will take full responsibility for all medical costs, as well as recovery costs, including physical therapy, should my pet ever bite anyone while on the premises.

**\*Excessive Matted Coat Release:** The skin under a severely tangled or matted coat will become very irritated and sensitive. Under the matting your animal's skin is usually red, swollen, cracked, and dangerous to groom. There are higher chances of nicking or cutting the skin during dematting and/or clipping. Pawsitively Perfect will not be held responsible for grooming injury in pets with matted coats. This also includes any after-grooming effects of matt clipping procedures, which could include, but are not limited to the following: itchiness, skin redness or self-inflicted irritations/abrasions from excessive external rubbing.

I am fully aware that Pawsitively Perfect encourages off-leash socialization and interaction of dogs in its custody and care and accordingly I assume any and all risks related to Pawsitively Perfect's performance of its services, including but not limited to bites, bodily injury, illness and disease, theft, falls, collisions with vehicles, natural disasters and death. I also agree to assume all liabilities, costs, damages, claims and expenses that may occur as a result of my pet's actions.

If, in my absence, my dog should be injured, become ill or suffer an ailment or is otherwise deemed by Pawsitively Perfect to require immediate medical attention, Pawsitively Perfect, in its sole discretion, is authorized to make all health care decisions on my behalf, and may utilize the service of a licensed veterinarian to administer medicine or give other requisite attention to my pet(s) at my sole expense. I hereby indemnify Pawsitively Perfect from any action, claim, demand or lawsuit (including attorney's fees) arising out of or connected with the charges made by any veterinarian caring for my dog(s).

I hereby certify and represent that my dog(s) is in good health and has not been ill with any communicable condition in the last 30 days. I also represent that my pet is current on its' vaccinations for Rabies, Bordetella, and DHLPP-PVO. I further certify that my dog has not harmed or shown aggressive or threatening behavior towards any person or any other dog or animal. I understand that Pawsitively Perfect reserves the right to refuse use of our facilities or to rescind attendance rights for dogs who, in Pawsitively Perfect's sole determination, act aggressively, are undisciplined, evidence inappropriate behavior or who might otherwise be a danger to themselves, other animals or people. I certify and represent that all of the information provided to Pawsitively Perfect in writing or otherwise relating to my dog and myself is true and correct.

I agree that my dog may appear on Pawsitively Perfect's website, face-book, and advertising from time to time.

I specifically represent that I am sole owner or agent of my pet(s), and that I am authorized to sign this contract. I will immediately notify Pawsitively Perfect of any changes to what I have represented above.
